## NEXT

The October meeting will be on the third Saturday, October 21 with bagels by the Moores at 8:30 as usual, but this month we are scheduled to meet in the meeting room, then move to the auditorium.

At press time Jim was not sure whether we would have the scheduled presentation of Windows Tools, or an outside speaker on the inside details of developing software. Or we might have Jim's programs on **Faces** which did not fit into the September panel.

## September Meeting

The regular meeting of HCC was held on Saturday, September 16, 2000, at the Hunterdon Medical Center. President Lon Hosford called the meeting to order at 9:30 A.M. Guests welcomed included Albert and Marie Kleiner of Flemington, and Rowland Carver, a Bell Lab retiree, treasurer of Lehigh Valley CC, guest of Harvey Schramm. LVCC has 270 members, about 50 of whom are active. He was interested in our experience and views on incorporating. Jac Carrol, our

treasurer, said he had spent a lot of time on the paper work and concluded it was not worth while for HCC. Jim Russ added that NJCC has completed 407C incorporation but he was also lukewarm about its value to the club.

The Kleiners had come to ask what they should plan for a computer room. Suggestions flowed. Waist high wall outlet strip. Wheels on the computer desk so you can roll it out and work on the back. Good lighting. Set the monitor facing away from any window. A prayer rug for times of crisis. A pullout keyboard shelf. Mouse holder. Heavy duty surge protector. Comfortable adjustable height chair. Good ventilation. Provision for the heat that the computer generates. Monitor placed away from thermostat. Fluorescent light. No carpet or only flat hard no pile carpet. Joe Burger said his computer desk is a flush door supported by a 2 drawer file cabinet at each end. 2 phone lines. If the computer room is below ground level leave the machine on all the time to combat humidity. Most agreed they leave machines on except for lightning. Lon said it's a good idea to turn the machine off now and then to let it clean itself up. Gateway recommends daily reboot. Use a static defuser before touching the machine. Rowland Carver said he had suffered \$700. Damage from lightning in the phone line. He also reminded us to store disks on top of monitors.

Lon started with a brief description of his work making videos for training in Cobal programming, to be shipped to India. He explained that Cobal was invented by Lt. Hopper, USN, and that her

programming language is now running computers around the world. Lon said a billion people in India are working in government supported and controlled research.

In new business, the president called for nominations for all officers. Carl Heitzman moved that all present officers be nominated. The motion was seconded and passed by unanimous voice vote. Lon announced that further nominations would be in order at the October meeting, according to the by-laws.



The Secretary's report covered continuing need for teachers at the Senior Center, and improvements in equipment and facility. See the article on Computer Volunteers. She urged people to look at the Adobe material on display, and noted that Adobe sends a lot of material to User Groups. She reported that Print Shop Deluxe v 11 will not install unless you let it first install MIE (Microsoft Internet Explorer) version 5. No fine print on the box tells this. It wants 1038 Mb for full installation, 6356 Typical and 450 Minimum. Minimum install requires having the CD in the drive, but Print Shop is infamous for disk switching anyway.

Treasurer Jac Carroll reported a balance of \$981.87. He commented fur-

ther about incorporating, saying he had had meetings with an accountant and a lawyer and has a folder full of forms and notes. Achieving non-profit status needs a lawyer club member. Jim said its value it is allows the club to give tax letters for donations, and limits the liability of the officers. Non profit groups pay no sales tax. [We pay tax only on newsletter copies and supplies. Our only other purchases are stamps and bagels.]

Don Colombo is back on the phone calling about renewals.

Webmaster Paul Glattstein noted that no one had asked to be removed from the member list on the web site (hunterdon-computerclub.org) He reported that sometimes his paper copy and the PDF file arrive together so that the letter is posted quite promptly.

Jim Russ, discussing programs, said that NJCC has suggested a joint meeting in order to insure attendance enough to get a presentation by Adobe, which requires a guarantee of 70 people. We would have some input on choice of topic.

Ed Matko and Jim Talbot came on down with winning tickets.

Vice President Joe Burger, in his tech report, said Amazon is accused of sharing names and addresses. He said net shoppers will need to shop early this year, because of increased volume. Many orders last year were never delivered. He discussed problems in the Tme-Warner\AOL merge. He gave www.sardata.com as an address to look at for news of how much harm your cell phone can do to your health. He described a new MP3 player ( \$500 ) that holds 1500 Mb with a 6 gig hard drive, runs 4 hours on 1 set of batteries, records enough to play 100 hours of music. In the goof department, Ikea posted 1000 names of people who requested catalogs.

Of MS Millenium OS, Joe said don't buy it. He cited a Mossberg column paning it. Joe said Millenium is a rehash of Win98, and that Win2000 is like NT.



## The Program

Peter Czerwinski followed up his previous presentations on taking pictures ( at high levels) with advice on how to share the results, over e-mail. He used **MS Photo Editor**. Other programs can do the same things.

First step: Crop. That is to say, trim the picture to remove extraneous areas, usually improving the picture.

The second step is to sharpen the picture, i.e. increase contrast.

Next is Auto-Balance. This deals with color, looking at the RGB balance. (red green blue)

Having modified the picture to suit, Peter recommended lowering image size to about 300x250 pixels. He chose a resolution size of 72 ppi. Then he Saved As Quality=low.jpg, ending with a 20 KB file that loads from a 28.8K modem in less than 10 seconds.

The object of this exercise is to send a picture without stalling your friend's email with an immense file, or boring him with a tedious, long, slow revelation on his screen, much of which consists of meaningless edges of sky or earth.

As usual, Peter's expert presentation led to lively questions and discussion. Peter mentioned flash cards that compress photofiles and create albums of up to 20 pictures.

Free at Radio Shack, or packed with Wireless, and other products, CueCat burst upon us free. At Radio Shack it was handed to you with a full Radio Shack catalog. Here's an e-mail description:

".....this is a device you attach to your computer which will scan any barcode either in an ad or off the product itself. If that product has a website, it will bring you to the URL!"

From the package description:

"The ...CueCat Reader will change the way you use the internet forever....reads any product code and instantly transports you to the corresponding web page associated with that product."

The package consists of a CD for installation and a "convergence cord" with a mouse reader that has ears (molded). You disconnect your keyboard at the back of the computer, plug in CueCat, plug your keyboard into the CueCat cable, answer "a few questions" and you're off. 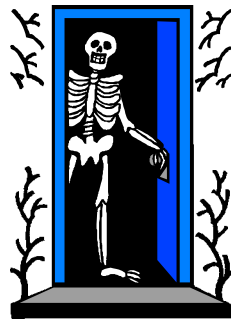

**Rick Williams** had more comments:

I'd replace the fluorescent tube from a local source or from the scanner manufacturer. Try local source first. Be careful not to upset the belts/gears which drive the moving parts of the scanner. Firmware, as I understand it, is somewhere between hardware and software.

It consists of digital instructions stored in a chip which control the actions of a specific device and which can be upgraded if the user so wishes, but often is not really necessary. Modems, for example, have firmware which can be upgraded over the internet and so increase the speed or accuracy etc. of the modem. The scanner in question evidently has upgradable firmware and performance may or may not be improved by an upgrade. Check the .com, or chat rooms for the brand to see if there are user comments or possibly a downloadable upgrade (for free.)
